Important Notations:

- **1. New Constitution:** Copies of the proposed Constitution will be emailed to you if you have provided your email address. Otherwise copies of the Constitution will be mailed out this week by ordinary post.
- 2. Proxy Form, Voting Schedule and Limited Power of Attorney: A current financial member who is entitled to attend and vote at the Special General Meeting is entitled to appoint a Proxy to attend and vote in their stead. A Form of Proxy and Voting Schedule are attached to this Notice of Meeting. The Proxy must be properly filled and lodged at the Registered Office by 5pm Monday 9 July 2007. We encourage you to mail your Proxy and Voting Schedule EVEN if you are intending to come to the Meeting, in case of emergencies. If you are intending to *travel overseas* at the time of the meeting you will need to get a Solicitor to witness your Limited Power of Attorney Form and attach it to your Proxy Form. A Member you know who is already overseas can get a Notary Public at the Australian Embassy in the country they are in to certify the Limited Power of Attorney and send it to us by Registered Airmail or FEDEX.
- **3.** Amended Annual Report and Audited Financial Statement for 2005-06 (incorporating changes to the year 2004-05) and the proposed amended Constitution shall be made available upon your request at the Registered Office before the Special General Meeting and copies will be made available at the meeting.
- **4. Employment of Consultant Office Manager under Contract:** Details of the Office Manager's appointment will be attached to this notice.

RATIONALE FOR NEW CONSTITUTION OF MAHBOBA'S PROMISE Inc.

After a lot of discussion and consultation the Management Committee strongly recommend that the Members agree to reject the current constitution as a whole, and to replace it with a whole new Constitution. A copy of the new proposed Constitution will be emailed to you if we have your email address or sent to you by post.

These changes are necessary under legislation and compliance with peak bodies governing our organisation's approval to raise funds in Australia for foreign aid overseas. The proposed new Constitution has a stronger and clearer set of rules by which Mahboba's Promise Inc. can continue to expand its operations so that it remains a transparent and responsible fund raiser for needy widows and orphans and to improve corporate governance.

The important new additions include:

- 1. The inclusion of the Name of the Association: "Mahboba's Promise Inc" which was missing.
- Addition of standard clauses relating to the non-profit nature of the organization and the distribution of funds on winding up the organization as required in keeping with our nonprofit status.
- 3. A revision of the Association's Objects in keeping with the change to a focus on development aid projects rather than welfare.
- 4. An additional Vision, Mission, Values and Principles statement required by the Australian Council for International Development.
- 5. Addition of clause specifying the financial year of the Association.
- 6. Addition of a clause permitting a paid worker to be a member of the Management Committee.
- 7. Insertion of clauses in the Objects confirming the Association's obligations under child protection and counter terrorism legislation.
- 8. Revision of qualifications for membership and membership of the Management Committee. The old Constitution mentioned corporate members meaning organisations, which we have never had.
- 9. The Term of Office of Management Committee members was changed from 1 year to 2 years to provide personnel commitment, continuity of experience and stability to the organisation.
- 10. Increased quorums at Management Committee meetings and general meetings so that natural justice and democratic principles are more obvious in line with a new level of commitment to accountability and transparency in the organisation.
- 11. Changes to permit members who are travelling overseas to preserve their vote by attaching a Voting Schedule to their Proxy Form and by completing the Limited Power of Attorney Form.
- 12. A clearer statement of the duties of the Office Bearers, namely: President, Vice President, Secretary and Treasurer, and a clearer statement of the roles and duties of ordinary Management Committee members.
- 13. A new clause defining the qualifications for and stipulating the necessity to appoint an Auditor required by the Department of Gaming, Racing and Charities.
- 14. Clearer statements of the meaning of conflict of interest by Management Committee members.
- 15. Removal of clauses which have had no effect within the history of Mahboba's Promise Inc.
- 16. Correction of typographical errors and correction of grammar and changes that increase ease of interpretation.
- 17. Addition as Appendices to the Constitution of a new Membership Application Form, a new Proxy Form, and a new Limited Power of Attorney Form.

Please support us in making these important changes by approving to completely replace our current Constitution in order to make our organisation stronger and more able to expand its operations.
